### ORDINANCE NO. 60

AN ORDER EXTENDING THE CORPORATE LIMITS OF THE CITY OF LONSDALE TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS

WHEREAS, A certain petition dated April 13, 1976, requesting annexation of the territory hereinafter described was duly presented to the council on the 29th day of April, 1976; and

WHEREAS, The quantity of land embraced within the area described in the petition and bounded as described is 40 acres of unplatted land, no part of which is included within the limits of. an incorporated city, village or bourough; and

WHEREAS, The petition was signed by the sole owner of the property described herein; and

WHEREAS, No objection to the annexation has been received from the town board, county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, A consent to annexation has been duly executed and received by the City of Lonsdale from the township within which the property now lies; and

WHEREAS, The land described in the petition abuts the city limits at the southeast boundary thereof;

The council of the City of Lonsdale, Minnesota, ordains:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; (3) that none of said territory is now included within limits of any city, village or bourough.

Section 2. Territory annexed. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof;

The Northeast Quarter (NE 1/4) of the Southwest Quarter (SW 1/4) of Section 25, Township 112 North, Range 22 West of the Fifth Principal Meridian, subject to Minnesota State Highway Easements of record, all in Rice County, Minnesota.

Section 3. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

Section 4. Effective Date of Annexation. This ordinance takes effect upon the filing of the certified copies as directed in Section 3 hereof.
