ORDINANCE NO.

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HAYFIELD TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ABUTTING UPON THE LIMITS OF THE CITY

WHEREAS, the territory described below is not presently within the corporate

limits of any incorporated city, village, or borough; and

WHEREAS, this territory abuts upon the corporate limits of the city at the western boundary thereof and is deemed to be urban in character; and

WHEREAS, this territory is owned in fee by the city;

The Çity Council of Hayfield ordains;

Section 1. Territory Annexed. The corporate limits of the city of Hayfield are hereby extended to include the unplatted property described as follows now owned

by the city:

That part of the Southeast Quarter of the Southwest Quarter (SE4 SW4) of Section 22, Township 105 North, Range 17 West, Dodge County, Minnesota, described as follows:

Beginning at the south quarter corner (S_4^1 Cor.) of said Section 22;

thence South 89 degrees 44 minutes 44 seconds West along the south line of said Sec. 22 a distance of 72.03 feet to a point on the east right-of-way line of the now Chicago and North-western Railroad;

thence North 00 degrees 10 minutes 22 seconds West along said east right-of-way line a distance of 1311.24 feet to a point on the north line of the Southeast Quarter of the Southwest Quarter and Sec. 22;

thence North 89 degreees 49 minutes 03 seconds East along said north line a distance of 63.42 feet to the northeast corner of said SE_4^1 SW $_4^1$ Sec. 22;

thence South 00 degrees 32 minutes 55 seconds East along the east line said SE_4^1 SW_4^1 a distance of 1311.24 feet to the point of beginning.

The said Tract contains 2.039 acres, more or less.

<u>Section 2</u>. <u>Filing</u>. The city clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located and the Minnesota Municipal Commission.

Section 3. Effective Date of Annexation. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 2.
