ORDINANCE NO. 100 Chap. 4.08B

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF FOSSTON TO INCLUDE CERTAIN UNINCORPORATED TERRITORY OWNED BY THE CITY OF FOSSTON AND ABUTTING THE CITY LIMITS OF THE CITY OF FOSSTON.

WHEREAS, certain territory hereinafter described is owned by the City of Fosston and abutts the City of Fosston and is deemed to be urban in character;

The City Council of the City of Fosston ordains:

Section 1. TERRITORY ANNEXED. The corporate limits of the City of Fosston, Minnesota, are hereby extended to include the unplatted territory hereinafter described, which territory is owned by the City of Fosston and abutts the City limits of the City of Fosston, to-wit:

The Easterly three hundred seventy-seven and 7/100ths (377.7) feet of that part of the Northwest Quarter (NW $\frac{1}{4}$) in Section Ten (10), Township One Hundred Forty-seven (147) North of Range Forty West of the Fifth Principal Meridian, in Polk County, Minnesota, lying south of the right of way of Polk County Road No. 1, also known as the Columbia Road, and north of the right of way of U.S. Highway No. 2, containing 8.56 acres, more or less.

Section 2. FILING. The City Clerk is directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor of Polk County, the Clerk of Rosebud Township, and the Minnesota Municipal Commission.

Section 3. EFFECTIVE DATE OF ANNEXATION. This Ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2 hereof.
