AN ORDINANCE AMENDING Ordinance
No. 1734 Reading to the Annexation of
Certain Unplatted Land in Section 15,
Township 107 North, Range 14 West,
Olmsted County, Minnesota,
THE COMMON COUNCIL OF THE CITY
OF ROCHESTER DO ORDAIN:
Section 1. Section 1 and Section 2 of
Ordinance No. 1734 are hereby amended
to read as follows:
Section 1. A pelition has then filed
with the Common Council of the City
of Rochester, Signed by a majority of
the owners of the land described herein, requesting the Common Council
to annex said land to the City of
Rochester, The land described in said
petition for annexation is located in
Cascade Township, Olmsted County,
Minnesota, and is described as follows:
That part of the southwest quarter
of the southeast quarter of Section 15,
Township 107 North, Range 14 West
of the Fifth Principal Meridian, Olmsted County, Minnesota, described, as
follows:
Commencing at the southwest corner of the southeast quarter of said
Section 15, thence northerity along the
west line of sald southeast quarter
540,00 feet to the point of beginning;
thence easterly parallel with the
south line of said southeast quarter
1016,00 feet; thence southerly parallel
with said west line of southeast quarter
1016,00 feet; thence southerly parallel
with said west line of southeast quarter
1016,00 feet; thence westerly parallel
with the south line of said southline of southeast quarter, thence easterly along said line a distance of
98,00 feet; thence westerly parallel
with the south line of said southeast quarter 1114,00 feet; thence
southerly along the west line of said
southeast quarter for the county of
01msted, and with the Minnesola Municipal Commission, and the Town Board of
Cascade Township has notified the City
of Rochester that it has no objections to
the annexation of the land above-described,
