



A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF HENNEPIN, MINNESOTA, PASSED AT A REGULAR MEETING HELD AT THE COUNTY SEALS CHAMBER, ST. PAUL, MINNESOTA, ON THE 14TH DAY OF MARCH, 1911.

Whereas, certain territory heretofore not included within the corporate limits of any incorporated city, village, or township within Hennepin County, this territory is completely surrounded on all sides by lands already included within the corporate limits of the city and is deemed to be urban in character;

Now, therefore, the City of Bemidji does ordain:

Section 1. Territory Annexed. The corporate limits of the City of Bemidji, Minnesota, are hereby extended to include the unplatted territory described as follows, which territory now is and heretofore has been completely surrounded by territory already included within the city limits:

South 120 feet of the north 357.27 feet of the W 200.4 feet of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$, Section 22, T146, R33.

North 235.27 feet of the W 352.4 feet of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ less the N 120 feet of the W 170 feet thereof, Section 22, T146, R33.

South 130 feet of the E 505.27 feet of the W 200.04 feet of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$, Section 22, T146, R 33.

South 4 rods of the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ and that part of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ lying SW of the line running from a point which is 40 rods east and 4 rods north of the SW corner thereof northwesterly to a point on the west line of said 40 which is 26 rods north of the SW corner thereof, Section 22, T146, R33.

North 120 feet of the W170 feet of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$, Section 22, T146, R33.

North 237.27 feet of the E 577.6 feet of the W 960 feet of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$, Section 22, T146, R33.

Section 2. Filing. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of Beltrami County and the Minnesota Municipal Commission.

Section 3. Effective Date of Annexation.

This ordinance shall take effect upon its passage and publication and the filing of certified copies as directed in Section 2.
