Alderman Willard Eason introduced the following Resolution and moved its adoption:

RESOLUTION APPROVING PETITION
FOR THE ANNEXATION OF LAND TO
THE CITY OF CHATFIELD, MINNESOTA.A

Whereas, a petition for annexing the real estate hereinafter described was made and executed by Harold N. Johnson and Betty A. Johnson, husband and wife, and filed with the City Clerk of this city on October 17, 1975, 1975; and,

Whereas, this Council has examined said petition, inquired of said petitioners and studied and considered the matters and the premises involved; and, has determined and found that said petition is proper, that the allegations contained therein are true, and that the annexation of the lands described therein will be for the best interests of the City of Chatfield, Minnesota, and the territory to be annexed;

Now, Therefore, It Is Hereby Resolved as follows:

1. That the petition of Harold N. Johnson and Betty A. Johnson, husband and wife, praying for the annexation of certain lands situate in the Southeast quarter of the Southwest quarter of section 4, township 104 North, range 11 West, County of Fillmore and State of Minnesota, is hereby approved.
2. That this Council hereby approves the annexation of the following described lands to the City of Chatfield, Minnesota, to-wit: Commencing, for a place of beginning, at a point 1319.3 feet East and 0.5 feet North of the Southwest corner of section 4, township 104 North, range 11 West, said point being at the intersection of the sixteenth section line in said section 4 with the centerline of U. S. Trunk Highway No. 52; running thence North along said sixteenth section line a distance of 474.7 feet, thence East a distance of 275 feet, thence South a distance of 475.8 feet to the centerline of U. S. Trunk Highway No. 52, thence North 88 degrees 23 minutes West along the centerline of U. S. Trunk Highway No. 52 a distance of 60.1 feet, thence a 4 degree curve along the centerline of U. S. Trunk Highway No. 52 a distance of 214.9 feet to the place of beginning.
3. That this Council recommends to the Minnesota Municipal Commission that the annexation of the aforesaid lands be approved and granted.
4. That the City Clerk is hereby authorized to make and forward such certified copies of these proceedings as shall be deemed necessary and/or expedient to the Minnesota Municipal Commission, Township Clerk for Chatfield Township, Fillmore County Auditor and Minnesota Secretary of State, as well as any other agency or political subdivision of the State of Minnesota, that may be necessary or required by law.
5. That the filing fee required by Minnesota Statutes, Chapter 414, and the Rules of Procedure be paid to the Minnesota Municipal Commission with and at the time of the filing of this Resolution and its attendant Ordinance.
6. That this Council hereby adopts an Annexation Ordinance relative to these proceedings as follows:


AN ORDINANCE ANNEXING CERTAIN LAND TO
THE CITY OF CHATFIELD, MINNESOTA.

The Council of the City of Chatfield, Minnesota, does ordain:


1. That the following described lands, situate in the Southeast quarter of the Southwest quarter of section 4, township 104 North, range 11 West, are hereby annexed to the City of Chatfield, Minnesota, to-wit: Commencing, for a place of beginning, at a point 1319.3 feet East and 0.5 feet North of the Southwest corner of section 4, township 104 North, range 11 West, said point being at the intersection of the sixteenth section line in said section 4 with the centerline of U. S. Trunk Highway No. 52; running thence North along said sixteenth section line a distance of 474.7 feet, thence East a distance of 275 feet, thence South a distance of 475.8 feet to the centerline of U. S. Trunk Highway No. 52, thence North 88 degrees 23 minutes West along the centerline of U. S. Trunk Highway No. 52 a distance of 60.1 feet, thence a 4 degree curve along the centerline of U. S. Trunk Highway No. 52 a distance of 214.9 feet to the place of beginning.

2. That, upon approval of this Ordinance by the Minnesota Municipal Commission, all plats inconsistent with this Ordinance shall be altered and modified to the extent of such inconsistency, but no further.




