ORDINANCE NO. 136

AN ORDINANCE RELATING TO ANNEXATION.

The City Council of Mountain Lake, Minnesota, ordains:

Section 1. Annexed Territory

The following-described territory is hereby annexed to the City of Mountain Lake, County of Cottonwood, and State of Minnesota, to-wit:

Tract situated in NW $\frac{1}{4}$ , Section 34, Township 106, Range 34, Cottonwood County, Minnesota, described as follows:  
Commencing at a point of intersection of the North boundary line of State Trunk Highway Number 60 with the East boundary line of County Aid Road (CAR) No. 1, this being the place of beginning; thence northerly along the east boundary line of said County Aid Road (CAR) No. 1, a distance of 285.50 feet; thence at right angle east a distance of 280.50 feet; thence at right angle south, parallel with said East boundary line of said County Aid Road (CAR) No. 1, to a point of intersection with the North boundary line of said State Trunk Highway No. 60; thence westerly along the North boundary line of said State Trunk Highway No. 60, to the place of beginning.

Section 2. Effective Date

This Ordinance becomes effective on the date of its passage. Passed by the City Council, this 3rd day of August, 1976.
