

IN THE MATTER OF THE APPLICATION

WHEREAS, the Honorable James F. Crowley, Judge of the  
Watonwan County Court, has heretofore filed with the undersigned  
Governor of the State of Minnesota his written application for  
retirement pursuant to the provisions of Minnesota Statutes,  
Sections 490.121, Subdivisions 13 and 14, and 490.124, Subdivision  
4, and

WHEREAS, the said Judge James F. Crowley has indicated  
in his application that he has become physically incapacitated  
from performing his judicial duties during the remainder of his  
term in office, and said condition being attested to by his personal  
physician, and

WHEREAS, the said Judge James F. Crowley has served as  
such judge and as such judge of a court of record for the past  
twenty-three (23) years, and

WHEREAS, the undersigned Governor of the State of  
Minnesota did, on July 20, 1976, make a determination according  
to law that the said Judge James F. Crowley has in fact become  
unable to perform his judicial duties,

NOW, THEREFORE, I, Wendell R. Anderson, Governor of the  
State of Minnesota, acting pursuant to the provisions of Minnesota  
Statutes, Sections 490.121, Subdivisions 13 and 14, and Section  
490.124, Subdivision 4, do hereby order and direct the retirement  
of the Honorable James F. Crowley, Judge of the County Court of  
Watonwan County, Minnesota to become effective at the close of  
business on August 31, 1976. He shall become entitled thereafter  
to retirement compensation as provided under the law, and I further  
direct that this Order be filed in the office of the Secretary of  
State of the State of Minnesota.





I have been seeing Judge Crowley since 1969 as primary care physician. He suffered from a giant follicle lymphoma which is a cancerous growth of the lymph glands. He was treated at the Mayo Clinic of Rochester, Minnesota with apparent good results. In March of 1976, he had a recurrence of his cancer and was again treated at Rochester with radiation. Subsequent to this treatment he began to have severe angina pectoris. On June 19, 1976 he suffered a myocardial infarct and is still hospitalized for his heart condition at Watonwan Memorial Hospital in St. James, Minnesota.

It is my feeling, with reasonable medical certainty, that Judge Crowley is totally disabled and will continue to be so disabled for the foreseeable future.

He has given us an enviable record locally as a Judge and we are sorry to lose him.
