Ordinance No. 160

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WADENA TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated March 31, 1975, requesting annexation of the territory hereinafter described was duly presented to the council on the 9th day of April, 1975; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described in approximately 10 acres of platted land, no part of which is included within the limits of an incorporated city, or borough; and

WHEREAS, the petition was signed by owners (by 8 owners, constituting a majority but not all of a total number of 14 owners); and

WHEREAS, no objections to the annexation have been received from the town board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, a hearing was duly held by the governing body of the City of Wadena, Minnesota, on the proposed annexation after at least 30 days mailed notice; and

WHEREAS, the land described in the petition abuts upon the city limits at the South boundary thereof;

The council of the City of Wadena, Minnesota, ordains:

Section 1. The city council hereby determines

- (1) that the annexation will be to the best interests of the city and of the territory affected;
- (2) that the territory described herein abuts upon the city limits and is urban or suburban in character; and
- (3) that none of said territory is now included within the limits of any city, or borough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

Lots Seven through Sixteen inclusive of Block Three;
Lots One through Eight inclusive of Block Four;
All of Block Five; all of Block Six and including all adjacent streets and roadways; all in Southbrook Addition to the Township of Wadena, Wadena County, Minnesota.

Section 3. Filing. The city clerk-treasurer is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Town Clerk, and the County Auditor.


Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.

Adopted by the council this 14th day of June, 1976.




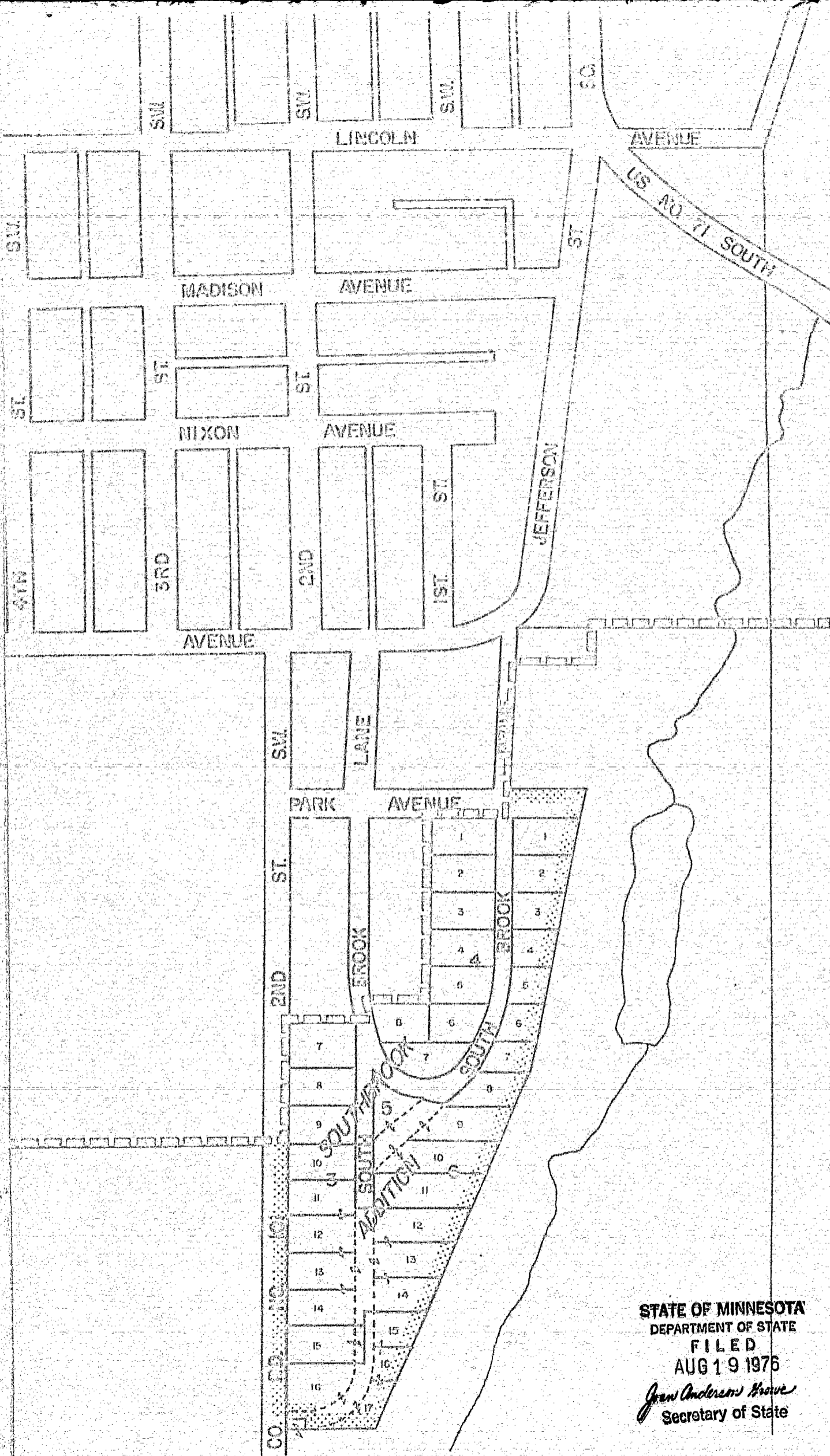
