AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLARS OF CLEARBROOK TO INCLUDE CARTAIN UNPLATTED LAND NOT EXCEPTING 200 ACRES IN AREA ABUTTING UPON THE VILLOR LIMITS

CRIMINES IN. OH

WHENEAS, A certain potition dated September 29, 1977, requesting annexation of the territory hereinafter described was duly presented to the Council on the 20th day of October, 1973; and

WHRELE, the quantity of land embraced within the area described in the petition and bounded as described is approximately one acre of unplatted land, no part of which is included within the lists of an incorporated city, village or borough; and

- WHEREAS, The potition was signed by all the unmors; and

WHIREAS, No objections to the annexation have been received from the town board, the county board, or any other party; and

WHEREAS, The land described in the petition abute upon the village limits at the southeast boundary thereof;

The Council of the Village of Clearbrook, Minnesota, ordains:

<u>Section 1.</u> The village council hereby determines (1) that the annexation will be to the best interests of the village and of the territory affected; (2) that the territory described herein abuts upon the village limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the village are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the village as effectually as if it had originally been a part hereof:

Seginning at a point 70 feet east of the Southeast corner of Block 2, Auditor's Subdivision to the Village of Clearbrook, as a point of beginning, thence east 140 feet; thence south 200 feet; thence west 140 feet; thence north 200 feet to the point of beginning. Said premises being part of the SWMSWM of Section 29-149-37 West of the Fifth Principal Meridian, less the north 50 feet of the above described tract, which is already a part of the Village of Clearbrook.

Together with all abutting streets.

And also the following parcel of land which is deeded to the public and recorded in Book 61 of Deeds page 242 in the office of the Register of Deeds, Clearwater County: Beginning at a point 210 feet east of the Southeast corner of Block 2, Auditors Subdivision to the Village of Clearbrook, Clearwater County, Minnesota, as a point of beginning, thence South 200 feet, thence West 140 feet, thence South 70 feet, thence East 160 feet, thence North 270 feet, thence West 20 feet to point of beginning. Said premises being a part of the S½SW¼ of Section 29-149-37 West of the Fifth Principal Meridian.

Section 3. Filing. The village clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
