WHEREAS, the said Judge George O. Murray has served as
such judge, or as such judge and as such judge of a court of
record for more than twenty-two (22) years, and

WHEREAS, the said Judge George O. Murray will have reached
the age of seventy (70) years,

NOW, THEREFORE, I, Wendell R. Anderson, Governor of the
State of Minnesota, acting pursuant to the provisions of Minnesota
Statutes, Section 490.121, Subdivision 12, do hereby order and
direct the retirement of the Honorable George O. Murray to become
effective at the close of business on October 31, 1976. He shall
become entitled thereafter to retirement compensation as provided
under the law, and I further direct that this Order be filed in
the Office of the Secretary of State of the State of Minnesota.
