AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LINDSTROM TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED (BORDERED) BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, or borough; and

WHEREAS, 60% or more of the perimeter of this territory is bordered by lands already included within the corporate limits of the city and is deemed to be urban in character; The City Council of Lindstrom ordains:

Section 1. <u>"erritory annexed</u>. The corporate limits of the City of Lindstrom, Minnesota, are hereby extended to include the unplatted territory 60% or more of the perimeter of which is bordered by territory already included within the city limits:

That part of Government Lot 6, Jection 34, Township 34 North, Kange 20 West, Chisago County, Minnesota, described as follows:

Beginning at a point 975 feet, more or less, south of the northerly line projected of Government Lot 6 on the westerly line of Irene Avenue; thence continuing routherly along said westerly line of Irene Avenue a distance of 80 feet, more or less; thence easterly a along the present Lindstrom City boundary to the shore line of North Center Lake; thence northwesterly along said shore line to the present Lindstrom City boundary on the north side of the tract herein described; thence westerly along the said boundary to the point of beginning.

Section 2. Filing. The city clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, the lown clerk of the affected township and the Minnesota Number Loard. <u>Section 3</u>. <u>Effective date of annexation</u>. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.
