AN ORDINANCE INCORPORATING INTO THE CITY LIMITS OF LYNDA
PROPERTY AS PETITIONED BY ALL THE PROPERTY OWNERS PUR-
SUANT TO M. S. 414.03

The Common Council for the City of Lynd do ordain as follows:

17.101

Section 1. That the following described property is hereby incorporated
with in the City Limits of Lynd:

That part of Section 27, Township 111 North, Range 42 West, described
as follows: Commencing at a point 12 rods east from the southwest
corner of the Northeast Quarter of the Southwest Quarter of Section 27,
thence north at right angles 16 rods, thence east at right angles 8 rods,
thence south at right angles 16 rods, thence west at right angles 8 rods
to the place of beginning. Containing 8/10 of an acre more or less.

All that part of Section 27, T. 111 N-Range 42 West of the 5th Principal
Meridian in Lyon County, Minnesota, described as follows: Commencing
at the intersection of the northeasterly line of Fourth Street with the
northwesterly line of Rice Street in the City of Lynd; thence northeasterly
along the northwesterly line of Rice Street 214.5 feet; thence northwesterly
at right angles 214.5 feet to the true point of beginning; thence northerly
and parallel with the West line of the NE1/4 of the SW1/4 of said Section
27 a distance of 200 feet; thence easterly at right angles 235 feet; thence
northerly and parallel with the west line of the NE1/4 of the SW1/4 of
said Section 27 a distance of 515 feet; thence easterly at right angles
142 feet; thence northerly and parallel with the West line of the NE1/4
of the SW1/4 of said Section 27 a distance of 415 feet; thence southwesterly
and parallel with Rice Street 480 feet to the true point of beginning and
containing 2.11 acres more or less. Excepting therefrom easements of
record.
