ORDINANCE # 196

An Ordinance Extending the Corporate Limits of the City of Big Lake to Include Unincorporated Territory Bordered on Three Sides by Land Within the City Limits and Abutting Thereon

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city; and

WHEREAS, this territory is bordered on three sides by lands already included within the corporate limits of the city and is deemed to be urban in character,

The City Council of Big Lake ordains:

Section 1. Territory Annexed. The corporate limits of the city of Big Lake, Minnesota, are hereby extended to include the platted and unplatted territory described as follows, which territory is and has heretofore been bordered on three sides by territory already included within the city limits:

That part of Sections 13 and 24 in Township 33, Range 28, in Sherburne County, Minnesota, beginning at the intersection of the centerline of Lake Shore Drive and Shady Lane in the plat of Edgewater Subdivision, in said County of Sherburne, thence Southwesterly and Westerly on and along the centerline of said Shady Lane and the Westerly extension of said centerline to a point that is 18 rods 13.2 feet west of the west line of said plat of Edgewater Subdivision; thence north parallel with said west line to an intersection with the South line of Section 13 in said Township 33, Range 28; thence West along the South line of said Section 13, to an intersection with the West line of Lot 12 in Block 1 of the plat of Oakland Heights in said County; thence northwesterly along the west line of said Lot 12 and the Northwestern extension thereof to the center line of Nicollet Avenue in said plat of Oakland Heights; thence, Northeasterly along the centerline of said Nicollet Avenue to an intersection with the Centerline of said Lake Shore Drive; thence, Southeasterly along the centerline of said Lake Shore Drive, to the point of beginning.

Section 2. Filing. The city clerk is directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor of Sherburne County and the Minnesota Municipal Commission.

Section 3. Effective Date of Annexation. This Ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.
