ORDINANCE NO. 128, 2ND

AN ORDINANCE EXTENDING THE CORFORATE LIMITS OF THE CITY OF EAST GRAND FORKS, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED LANDS, THE PERIMETER OF WHICH IS 60% OR MORE BORDERED BY LAND WITHIN CITY LIMITS AND ABUTTING THEREON.

CITY LIMITS AND ABUTTING THEREON.
WHEREAS, certainlands described below are not presently included within the corporate limits of any incorporated city, village or borough, said lands being situated in Grand Forks Township, Polk County, Minnesota; and

WHEREAS, the City Council of the City of East Grand Forks, Minnesota, finds that Sixty (60%) percent or more of the perimeter of the lands hereinafter described are bordered by lands already within the corporate limits of the City of East Grand Forks, Minnesota; and,
WHEREAS, said City Council further finds that considerable commercial and industrial development has taken place in the land area hereinafter described, is deemed to be urban in character, and that it would be to the best interest of the municipality and of the territory affected that it be annexed to the City of East Grand Forks, Minnesota; and,
WHEREAS, Notice of Intent to

affected that it be annexed to the and. City of East Grand Forks, Minnesota; and,

WHEREAS, Notice of Intent to Annex the said lands as hereinafter described, was personally served upon the Town Board of Grand Forks Township, on the twenty-third (23rd) day of April, 1976, and more than sixty (60) days have elapsed since service of said Notice of Intent to Annex, and no written objections to the said annexation have been submitted to the Municipal Commission of the State of Minnesota or to the City of East Grand Forks, Minnesota, by said Town Board of Grand Forks Township.

The City of East Grand Forks Ordains:
Section 1. Territory Annexed. The corporate limits of the City of East Grand Forks Grand Forks, Minnesota, are hereby extended to include the unplatted lands described below, sixty (60%) percent or more of the perimeter of said lands being bordered by lands already included within the corporate limits of the City of East Grand Forks, Minnesota; said lands being deemed urban in character and the annexation of which would be to the best interests of the said city and the territory affected, said lands being described as follows, to wit:


