AN ORDINANCE ANNEXING CERTAIN LANDS AND EXTENDING THE CORPORATE LIMITS OF THE CITY OF GRANADA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRANADA, MINNESOTA AS FOLLOWS:

Section 1. The property hereinafter described abuts upon the corporate limits of the City of Granada, Minnesota. Said land consists of 12.113 acres and is unplatted. A Petition was signed by Michael J. Starks and Parlene H. Sparks, the sole owners of said land, requesting that said land be annexed to the City of Granada, Martin County, Minnesota, pursuant to the provisions of Minnesota Statutes 414.033, Subdivision 5. A copy of said petition was filed with the chairman of the Center Creek Township Board, Martin County, Minnesota; the Board of County Commissioners, Martin County, Minnesota; the Municipal Council of the City of Granada and the "unicipal Commission of the State of Minnesota. More than sixty days have elapsed since said service and no objections to said annexation have been filed. It appears that the best interest of the municipality and the territory affected will be served by annexing said territory to the City of Granada.

Section 2. The following described property located in the County of Martin, State of Minnesota, is herewith annexed to the City of Granada:

A tract of land in the Mortneast Quarter of the Morthwest Quarter of Section 29, Township 103 Morth, Pange 29 West of the Fifth Principal Meridian, Martin County, Minnesota more particularly described as follows:

Beginning at the Southeast Corner of Lot 58 of Auditors Plat in the Village of Granada said corner being the Southwest corner of the Northeast Quarter of the Northwest Quarter of said Section 29; thence North 90 degrees 00 minutes 00 seconds East along the South line of the Northeast Quarter of the Northwest Quarter of said Section 29 a distance of 810.70 feet to a point on the Northwesterly Right of Way line of the Chicago, Milwaukee, St. Paul and Pacific Railroad; thence North 65 degrees 40 minutes 00 seconds East along the Northwesterly Right of Way line of said Railroad a distance of 12.25 feet; thence North 01 degrees 34 minutes 54 seconds West a distance of 644.87 feet; thence South 89 degrees 58 minutes 16 seconds West a distance of 802.89 feet to the Northeast corner of said Lot 58 of Auditors Plat; thence South 00 degrees 06 minutes 14 seconds West along the East line of said Lot 58 of Auditors Plat, said East line being the West line of the Northeast Quarter of the Northwest Quarter of said Section 29 a distance of 649.27 feet to the point of beginning, containing 12.113 acres more or less subject to easements now of record in said county and state.

Section 3. This Ordinance shall be in full force and effect from and after its passage and publication and the filing of certified copies thereof with the Municipal Commission, the Martin C ounty Auditor, the Secretary of State, the Register of Deeds for Martin County and the Town Clerk of the Township of Center Creek, all in the State of Minnesota.
