Dear Sir: ATTENTION: CORPORATION DIVISION.

Your letter of June 21, 1923, relative to the McCaskey Register Company of Minneapolis, Minnesota, and Alliance, Ohio, received.

You enclosed with that letter an affidavit from J. N. Swift of 2012 Hennepin Avenue, stating that the McCaskey Register Company was not licensed in the State of Minnesota, but that they had sold goods to the Queens Joy Cafe of Minneapolis, Modern Auto Company, Minneapolis, and H. J. Casey, Minneapolis.

After making a careful check and having considerable correspondence with the McCaskey Register Company at Alliance, Ohio, we find that the Modern Auto Company, 304 East Lake Street, bought supplies and duplicate sales books amounting to \$83.50. They were expressed on March 24, 1923, from Alliance, Ohio.

H. J. Casey, 3020 W. 5th St., Minneapolis, bought accounting register and supplies amounting to \$130.50, which was shipped by express from Alliance, Ohio.

The Queens Joy Cafe, 819 Hennepin Avenue, state that they never purchased anything from the McCaskey Register Company.

In going over the business with Mr. Butcher, the General Manager of the Minneapolis branch, I find that they have a number of salesmen in the city and on the road out of the Minneapolis office, but that the McCaskey Company does not ship or deliver any goods of any description out of the Minneapolis office.

Hoping that the above information will satisfy your office as per complaint on the above mentioned date, I remain,
