ORDINANCE NUMBER 1295

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED LAND ADJUTTING THE CITY OF AUSTIN LIMITS.

WHEREAS, a certain petition dated March 17, 1976 requesting annexation of the territory described herein was duly presented to the Common Council on the 4th day of May, 1976, and,

WHEREAS, the quantity of land embraced within the area described in the petition is approximately .70 acres of platted land, no part of which is included within limits of any incorporated city, village, or borough,

WHEREAS, the petition was signed by all the owners, and,

WHEREAS, no objections to annexation have been received from the town board, the county board, or the governing body of any municipalities whose boundaries abut upon the land to be annexed,

WHEREAS, the land described hereinafter abuts the City Limits on the south boundary thereof.

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION I: The City Council hereby determines that the annexation will be in the best interests of the City and of the territory affected. That the territory described herein abuts the City Limits and is urban or suburban in character and that none of the said territories now included within the limits of any city, village, or borough.

SECTION II: The corporate limits of the City of Austin are hereby extended to include the platted land described as follows, and the same is hereby annexed to, and included within the City as effectually as if it had originally been a part thereof:

Beginning at the northeast corner of Section 16, Township 102, North Range 18 West, Mower County, Minnesota, thence westerly along the north line of said section a distance of 183 feet to the northwest corner of Outlot 57 of Southgate First Addition thence south along the southerly extension of the west line of said Outlot 57 167.49 feet to the southwest corner of Outlot 60 of Southgate First Addition thence east along the south line of Outlot 60 extended easterly a distance of 183 feet to the east line of said Section 16 thence northerly along said section line to the point of beginning.

SECTION III: The City Recorder is hereby directed to file Certified copies of this Ordinance with the Minnesota Municipal Commission, the Austin Township Clerk, County Auditor, Register of Deeds, Austin Utilities, and the Secretary of State.

SECTION IV: The Ordinance takes effect upon its passage and publication and filing of the Certified copies as directed in Section III.
