

ORDINANCE NO. 536

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF
THE CITY OF BEMIDJI TO INCLUDE CERTAIN UNINCOR-
PORATED TERRITORY COMPLETELY SURROUNDED BY
LAND WITHIN THE CITY LIMITS

Whereas, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough; and

Whereas, this territory is completely surrounded on all sides by lands already included within the corporate limits of the city and is deemed to be urban in character;

Now, therefore, the City of Bemidji does ordain:

Section One. TERRITORY ANNEXED.

The corporate limits of the City of Bemidji, Minnesota, are hereby extended to include the unplatted territory described as follows, which territory now is and heretofore has been completely surrounded by territory already included within the city limits:

E 75' of the W 1035' of the N. 237.27' of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$, Section 22-
T146, R33.

Section Two. FILING.

The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of Beltrami County and the Minnesota Municipal Commission.

Section Three: EFFECTIVE DATE OF ANNEXATION.

This ordinance shall take effect upon its passage and publication and the filing of certified copies as directed in Section 2.


