ORDINANCE NO. 80

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF SANBORN TO INCLUDE CERTAIN UNPLATTED LANDS ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition dated August 5, 1975; and

WHEREAS, the quantity of land contained within the area described is 36 acres of unplatted land, no part of which is included within the limits of the City of Sanborn,

WHEREAS, the petition was signed by all owners, and

WHEREAS, no objections to the annexation have been received from the town board, and

WHEREAS, a hearing was held by the governing body of the City of Sanborn, Minnesota, on the proposed annexation, and

WHEREAS, the land described in the petition abuts upon the City limits at the west edge thereof;

THE COUNCIL OF THE CITY OF SANBORN, MINNESOTA, ORDAINS:

SECTION 1.

The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is suburban in character; and (3) that none of said territory is now included within the limits of any City.

SECTION 2. TERRITORY ANNEXED

The corporate limits of the City are hereby extended to include the unplotted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof: the South 1404.00 feet of the Southwest quarter (SW¹/₄) Section 26, Township 10ⁿ North, Range 36 West of the Fifth Principal Meridian, Redwood County, Minnesota, containing 35.53 acres more or less subject to easements now of record in the County and the State.


SECTION 3. FILING

SECTION 4. Effective Date


This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
