REORGANIZATION ORDER NO. 76

Pursuant to Minnesota Statutes 1974, Sections 16.125, 16.13 and 16.135, the following administrative reorganization is made.

In order to promote efficiency in the operation of the Public Employment Relations Board (PERB) and to alleviate the appearance of any conflict of interest between the Board and the Bureau of Mediation Services, the functions of the Board along with the following position are hereby transferred from the Bureau of Mediation Services to the Department of Labor and Industry.

In conjunction with this reorganization order, the cost of salary and fringe benefits for the aforementioned position (\$11,932 salary, \$1,414 retirement and FICA, \$281 insurance) is transferred from the Bureau of Mediation Services (appropriation number 21700:01-10) to the Department of Labor and Industry (21400:01-10). It is also authorized that \$4,000 be transferred from the Bureau of Mediation Services for the PERB activity (21700:02-10, AID 260364) to the Department of Labor and Industry (21400:02-10) for supplies and expense. Furthermore, the salary portion of the PERB activity of \$6,220 which includes per diem for board members (21700:01-10, AID 260323) must be transferred to the Department of Labor and Industry (21400:01-10).

The legislative complement of the Bureau of Mediation Services is decreased by one position and the legislative complement of the Department of Labor and Industry is increased by one position. The position established in Labor and Industry is in the unclassified service and will function as Executive Secretary to the Board.

The Commissioner of Finance is authorized to complete this transfer.

This order is effective September 1, 1976.
