ORDINANCE
AN ORDINANCE EXTENDING THE
CORPORATE LIMITS OF THE CITY
OF HACKERSACK TO INCLUDE
CERTAIN UNINCORPORATED
UNPLATTED LAND NOT
EXCEEDING 200 ACRES IN AREA
ABUTTING UPON THE CITY LIMITS.
WHEREAS, a certain petition
dated April 30th, 1976, requesting
annexation of the territory hereinafter,
described was duly presented to the
council on the 3rd day of May, 1976;
and

described was duly presented to the council on the 3rd day of May, 1976; and WHEREAS, the quentity of land ombraced within the area described in the petition and bounded as described is eight (8) acres of unplatted land, no part of which is included within the limits of an incorporated city, or borough; and WHEREAS, the petition was signed by all owners; and WHEREAS, no objections to the annexatign have been received from the town board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and WHEREAS, the land described in the petition abuts upon the city limits at the southerly boundary thereof; The council of the City of Hackensack, Minnesota ordains:

Section 1. The city council hereby determines (1) that the annexation will be to the best interests of the city and of the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, or borough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

That portion of the Southeast Quarter of the Southwest Quarter (SEVSWV4) of Section Nineteen (19), Township One Hundred Forty (140), Range Thirty (30), described as follows: Beginning at the southeast corner of said Southeast Courter of the Southwest Quarter (SEVSWV4), thence North 89 degrees 44 minutes West 367.98 feet to the easterly right-of-way line of the N.P. Railway, presently Burlington Northern Railway, thence Northwesterly along said right-of-way line 149.85 feet to the center line of the County Road, thence North 69 degrees 12 minutes East 420.50 feet to the East line of said Southeast Quarter of the Southwest Quarter of the Southwest Quarter of the Southwest Quarter of the Southwest Quarter (SEVSWV4), thence South 00 degrees 10 minutes East 298.60 feet along said East line to the point of beginning. AND ALSO: All that portion of the Northeast Quarter (NEVANWV4), of Section Thirty (30), Township One Hundred Forty (140), Range Thirty (30), Tyling and being East of the Burlington Northern Railway right-of-way, Section 3. Filing. The city cierk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Town Cierk, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication, and the filling of the certified copies as directed in Section 3. Adopted by the council this 2nd day of August, 1976.
