AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF BAGLEY TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA AND CERTAIN PLATTED LAND ADJUTING UPON THE CITY LIMITS.

WHEREAS, A certain petition requesting annexation of the territory hereinafter described was duly presented to the City Council on July 22, 1975; and

WHEREAS, The quantity of land embraced within the unplatted area described in the petition is approximately one and one-half acres of land, no part of which is included within the limits of an incorporated city; and

WHEREAS, The petition was signed by all the owners; and

WHEREAS, No objections to the annexation have been received from the Town Board, the County Board or any other party; and

WHEREAS, The land described in the petition abuts upon the city limits at the northwest and north boundaries thereof;

THE CITY COUNCIL OF BAGLEY, MINNESOTA, ORDAINS:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the platted land and the unplatted land described as follows, and the same is hereby annexed to and included within the city as effectually as if it had originally been a part hereof:

Block One (1), Berg's Subdivision, according to the plat thereof on file and of record in the office of the Register of Deeds in and for said county.

Commencing at a point 380 feet east of the east boundary line of County Aid Road No. 9 and 70 feet north of the south line of the SE1/4SW1/4 of Section 20, Township 147 North, Range 37 West, of the Fifth P.M., thence East a distance of 380 feet, on a line parallel with the south line of the above described forty acre tract, thence at right angles and north on a line parallel to the east line of said described forty, a distance of 165 feet, thence at right angles and west on a line parallel to the aforesaid south line of said above described forty, a distance of 380 feet, thence at right angles and south on a line parallel to the aforesaid east line of said forty, a distance of 165 feet, to the place of beginning, containing one and one-half acres, more or less, and being located in the SE1/4SW1/4, Sec. 20-147-37.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
