

ORDINANCE NO. 43-A SECOND SERIES

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HASTINGS TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a petition has been received, requesting annexation to the City of Hastings of the property described in said petition, which petition was filed:

By Willia J. Olson regarding the East one-half of the Northeast Quarter (Ex of NE%) of Section 3, Township 114, Range 17, Dakota County, Minnesota, containing 80 acres, more or less, according to Government Survey.

WHEREAS, the quantity of land embraced within said petition is less than 200 acres, unplatted land, no part of which is included within the limits of an incorporated City or borough; and

WHEREAS, the petition was signed by the sole owner of the property; and

WHEREAS, no objections to the annexation has been filed with the Minnesota Municipal Board according to advices from the Minnesota Municipal Board, nor has an objection to the annexation been received by the City of Hastings from the Town Board or the governing body of any other municipality; and

WHEREAS, said parcal abuts upon the southerly limits of the City of Hastings;

NOW, THEREFORE:

The City Council of the City of Hastings in Dakota County, Minnesota, does ordain:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interest of the City and of the territory affected; (2) that the territory described in the petition abuts upon the City limits of the City of Hastings, and is about to become urban or sub-urban in character; (3) That none of said property is now included within the limits of any city or borough.

Section 2. Territory Annexed. The corporate limits of the City

of Hastings is hereby extended to include unplatted lands described as follows, and the same is hereby annexed to include within the City as effectually as if it had originally been a part thereof:

The East one-half of the Northeast Quarter of Section 3, Township 114, Range 17, Dakota County, Minnesota, containing 80 acres, more or less, according to Government Survey; and

Section 3. Filing. The City Clerk is hereby directed to file a certified copy of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk of Marshan Township and the County Auditor of Dakota County.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copy. as directed in Section 3.
