

CHAPTER NO. 391

AN ORDINANCE ANNEXING CERTAIN LANDS

TO THE CITY OF SAUK CENTRE

THE CITY OF SAUK CENTRE DOES ORDAIN:

Section 1. That the following described real property adjoins the city limits of the city of Sauk Centre, and the perimeter of the area of the said land is sixty (60) percent or more bordered by the present boundary limits of the said city. The said property being in the County of Stearns, State of Minnesota, to-wit:

Lots 28 and 37 of Auditor's Subdivision of the West Half of Section 10 and the Northeast Quarter of the Northeast Quarter of Section 9, Township 126, Range 34, except those parts now situated in the corporate limits of the City of Sauk Centre. Also, the West Half of the Southwest Quarter of the Southeast Quarter and that part of the West Half of the Northwest Quarter of the Southeast Quarter lying South of County Highway #7, in Section 10, Township 126, Range 34, consisting of approximately 70.00 acres.

Section 2. That notice of intent to annex the said lands, now situated in Sauk Centre Township, was served on the Clerk of Sauk Centre Township on the 10th day of May, 1975, and that no objections to the said Petition have been made by the said Township of Sauk Centre.

Section 3. That it will be in the best interest of the said City of Sauk Centre that the said lands be annexed to the said City, and said lands are hereby annexed, taken into, and are hereby made a part of the said City of Sauk Centre, in Stearns County, Minnesota.

Section 4. That this Ordinance will take effect and be in force thirty (30) days after its publication.

The foregoing Ordinance was duly passed and adopted at a meeting of the City Council, held on the 5TH day of NOVEMBER, 1975.

CITY OF CANTON, MINN-
ESOTA

AN ORDINANCE ANNEX-
ING CERTAIN LANDS TO
THE CITY OF CANTON, MINN-
ESOTA THE CITY COUNCIL
OF THE CITY OF CANTON
ORDAINS:

Section 1. The following
described land situated in the
County of Fillmore, State of
Minnesota, shall be and here-
by is annexed to the City of
Canton, Minnesota:

Beginning at a point 59.5
feet south of the northeast
corner of the south half
of the southwest quarter
of Section 20, Township 101
north of Range 9 west, run-
ning thence south 153 feet,
thence north 59 degrees and
30 minutes west, 697 feet,
along the north side of rail-
road right-of-way to the
south side of the State High-
way, thence along the south
side of said Highway to the
point of beginning, contain-
ing 87/100 of an acre, more
or less.

Section 2. It is hereby
determined and declared that
said annexation is in the best
interests of the City of Canton
and of the said territory here-
by annexed.

Section 3. This ordinance
is passed pursuant to the pro-
visions of Minnesota Statutes,
Sec. 414.033, subd. 5.

Section 4. This ordinance
shall take effect from and af-
ter the 31st day of December,
1975.
