

**ORDINANCE NO. 172  
AN ORDINANCE ANNEXING  
CERTAIN PROPERTY TO THE  
CITY OF LE ROY, MINNESOTA:**

WHEREAS, all the owners of the premises hereinafter described have petitioned the City Council that said premises be annexed to the corporate limits of the City of Le Roy, Minnesota and that said premises are contiguous to and adjoining the City of Le Roy, and subject to incorporation within the corporate limits of Le Roy, Minnesota, by petition to the governing body of the City of Le Roy:

AND WHEREAS, due notice has been given to the Township of Le Roy, Commissioners of Mower County and the Municipal Commission of the State of Minnesota:

NOW THEREFORE, the City Council of the City of Le Roy, Mower County, Minnesota do ordain:

Section 1. The land hereinafter described shall be added to and incorporated within the corporate limits of the City of Le Roy, and said City Council does hereby declare said premises hereinafter described to be incorporated within and to be a part of the City of Le Roy, described as follows:

Starting at the north quarter corner of Section 34 — T101N — R14W;

thence 846 feet south along the west line of the northeast quarter of said section:

thence 33 feet east at a deflection angle of 89 degrees 53' left, to a point which is hereinafter called the point of beginning;

thence 110 feet east on an extension of the last described line;

thence 200 feet south at a deflection angle of 89 degrees 53' right;

thence 110 feet west, at a deflection angle of 90 degrees 07' right, to a point which is 66 feet east and 6.5 feet south of the southeast corner of Lot 18, Block 10, Caswell and Lewis Addition to the Village of Le Roy;

thence 200 feet north at a deflection angle of 89 degrees 53' right, on a line parallel to the west line of the northeast quarter of Section 34 — T101N — R14W, to the point of beginning;

being part of the NW¼ NE¼ Section 34 — T101N — R14W; and containing 0.505 acres.

Section 2. This Ordinance shall be in full force and effect from and after its passage and publication.
