ORDINANCE NO. 1.7012

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MADELIA TO INCLUDE CERTAIN—UNINCORPORATED PLATTED LAND ABOTTING UPON THE CITY LIMITS

MMEMBAS A Certain petition dated September 21, 1975, requesting annexation of the territory hereinafter described was duly presented to the Council on the 22nd day of September, 1975;

AND UMEREAS the quantity of land embraced within the area described in the petition and bounded as described is less than one-half acre of platted land, no part of which is included within the limits of an unincorporated city, village or borough.

AND WHEREAS the petition was signed by all the owners of said property.

AND UNEREAS no objections to the annexation have been received from the Madelia Township Board, the Matonwan County Commissioners or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed.

AND UMERRAS said land is urban in character or about to become so.

AND WHEREAS the land described in the petition abuts upon the City at the east boundary thereof.

NCM, THEREFORE, the Council of the City of Madelia hereby ordains as follows:

Section 1.

- A. The City Council hereby determines that the annexation will be to the best interests of the City and to the territory affected.
- B. The territory described herein abuts upon the city limits and is urban or suburban in character.
- C. That none of said territory is now included within the limits of any city, village or borough.

Section 2.

The corporate limits of the City are hereby extended to include the platted land described as follows and the same is hereby annexed to include within the city as effectively as if it had originally been a part thereof:

Lot A of Drigger's Subdivision of the West One-Half of the Northwest Quarter of Section 26, Townshp 107, Range 30, less the South 60 feet of the West One-Half of said Lot A.a Also excepting therefrom a tract of land conveyed to the State of Minnesota, said conveyance being recorded on June 20, 1974, as File No. 120, Card 1659 of the Watonwan County Records.

Section 3.

The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Watonwan County Auditor, and the Clerk of the Madelia Township Board.

Section 4.

This ordinance takes effect upon its passage and publication and filing of

certified copies as directed in Section 3.
