

ORDINANCE DECLARING CERTAIN UNPLATTED LAND  
TO BE ANNEXED TO THE CITY OF  
NORTH MANKATO, MINNESOTA

The Common Council of the City of North Mankato,  
Minnesota, does ordain as follows:


Section 1. The following tract of land lying adjacent  
to the City of North Mankato and being in the County of Nicollet  
and described as follows:

The Northwest Quarter of the Southwest Quarter of  
Section 1, Township 108 North, Range 27 West  
lying Northwesterly of the right-of-way of  
Minnesota Trunk Highway No. 14, together with any  
and all streets, highways or other public rights  
of way within and adjacent to said described land,  
some of which right-of-way lies within the North-  
east Quarter of the Southwest Quarter (NE $\frac{1}{4}$ SW $\frac{1}{4}$ ) of  
Section 1-108-27. Containing 36 acres of land,  
more or less, all in Nicollet County, Minnesota,

is hereby annexed and declared to be a part of the City of  
North Mankato and to be included in the corporate limits  
thereof.


Section 2. This ordinance shall take effect from and
