Be it further resolved that T. A. Haugen, Nels R. Oien and Peter Tuff, be and they hereby are appointed as inspectors to act as Judges at said ~~election~~ election.

TO THE COUNTY BOARD OF HENNEPIN COUNTY, MINNESOTA.

Come now the undersigned petitioners and respectfully represent that the said petitioners are voters residing upon the land hereinafter mentioned and described being the same proposed to be incorporated as a village under the laws of the State of Minnesota.

That the town-site of Halma, in the County of Hennepin and State of Minnesota is included within the said land so proposed to be incorporated;

That the said town-site of Halma has been platted into lots and blocks and said plat has been duly and legally certified according to the laws of the State of Minnesota, and filed in the Office of the Registrar of Lands in and for said County.

And the said petitioners further represent that the said land proposed to be incorporated as a village under the laws of this State are as follows, viz:

The Southwest quarter (SW $\frac{1}{4}$ ) of section twenty one (21) The South half of Southeast quarter (S $\frac{1}{2}$  of SE $\frac{1}{4}$ ) of section twenty one (21) The North half of Northwest quarter (N $\frac{1}{2}$  of NW $\frac{1}{4}$ ) and the North half of Northeast quarter (N $\frac{1}{2}$  of NE $\frac{1}{4}$ ) and the Southwest quarter of Northeast quarter (SW $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of section twenty eight (28) The Northwest quarter of Northwest quarter (NW $\frac{1}{4}$  of NW $\frac{1}{4}$ ) of section twenty seven (27) The Northeast quarter of Northeast quarter (NE $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of section twenty nine (29) The East half of Southeast quarter (E $\frac{1}{2}$  of SE $\frac{1}{4}$ ) of section twenty (20) all in township one hundred sixty (160) North of Range forty six (46) West of the 5th. 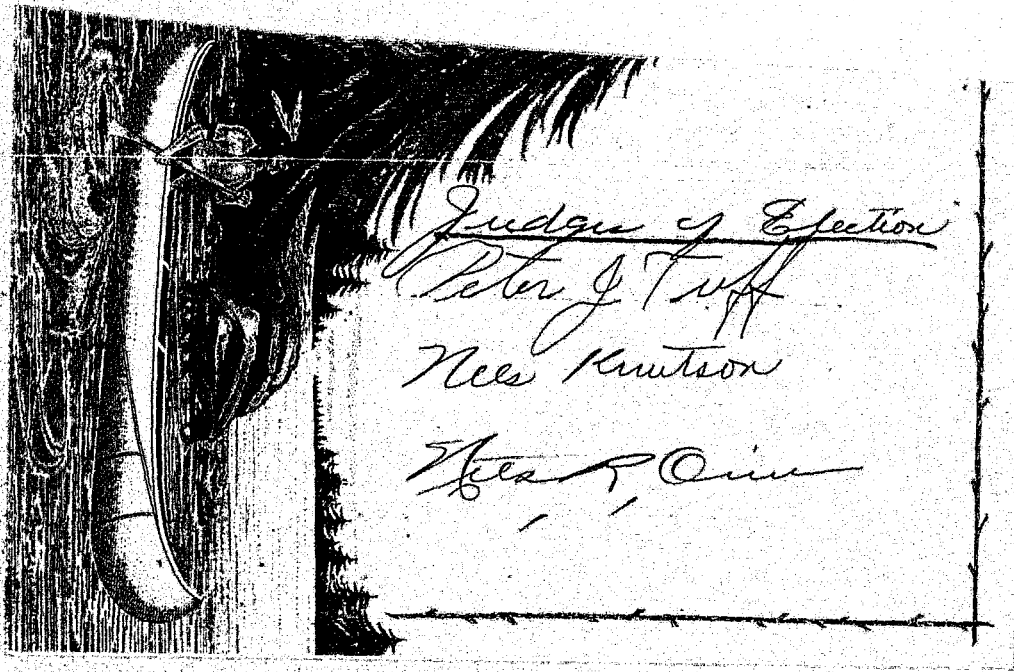




