ORDINANCE NO. 159

AN ORDINANCE ANNEXING CERTAIN PLATTED AND UNPLATTED
LANDS TO THE CORPORATE LIMITS OF THE CITY OF OLIVIA

The City Council of the City of Olivia, Renville County, Minnesota,
does hereby ordain as follows:

1.) The Corporate limits of the City are hereby extended to
include the platted and unplatted land described as follows and the
same is hereby annexed to and included within the City as effectually
as if it had originally been a part thereof:

- A.) Ledebøer's Outlot One (1) and Outlot Three (3);
- B.) Lot One (1), Block One (1), Ledebøer's Outlot Two (2);
- C.) Lot One (1) and Lot Two (2) of Dispanet Acres;
- D.) The West 790.6 feet of that part of the Southeast Quarter
(SE $\frac{1}{4}$) of Section Eleven (11), Township One Hundred Fifteen
(115), Range Thirty-five (35), lying between the South line
of the right-of-way of the C.M.St. P. & P. Railway Company
and the center line of TH 212.
- E.) That portion of the Southeast Quarter (SE $\frac{1}{4}$) of Section
Eleven (11), Township One Hundred Fifteen (115), Range
Thirty-five (35), lying North of the center line of State
Trunk Highway 212 across said quarter section and South
of the South line of the C.M.St. P. & P. Railway right-of-
way and East of the East line extended of Lot One (1),
Block One (1), Ledebøer's Outlot Two (2), in said Section
Eleven (11).

2.) The City Clerk is hereby directed to file certified copies
of this Ordinance with the appropriate offices of the Minnesota
Municipal Commission, Secretary of State and the County Auditor.

3.) This Ordinance shall take effect from and after its passage
and publication and filing thereof as provided by law.
