Ordinance So 150

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MEADOMLANDS TO INCLUDE CER-TAIN UNINCORFORATED LAND NOT EXCEPTING 200 ACRES ABUTTING UPON THE CITY LIMITS. WHEREAS, a certainpetition dated May 6, 1975, requesting annexation of the territory hereinafter described was duly presented to the council on the 6 day of May, 1975; and WHEREAS, The quanity of land embraced within the area described in the petition and bounded as described 0.96 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and WHERMS, the petition was signed by all owners; and

WHEREAS, no objection to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

NHEREAS, the land described in the petition abuts upon the city limits at the northern boundary thereof;

The council of the City of Meadowlands, Minnesota, ordains:

Section 1 The city council hereby determins (1) that the annixation will be to the best interest of the city and of the tarritory affected; (2) that the territory described herein abuts upon the city limits and is(is about to become) urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2 Territory Annexed The corporate limits of the city are hereby extended to include the unplatted land described as follows and the some is hereby annexed to and included within the city as effectually as if it has originally been a part therof: That part of the Northwest Quarter of the Northeast (NA: OF NE,), Section Twentytwo (22), Township Fifty-three (53), Range Nineteen (19), Beginning at a point on the North line of sold Northwest Quarter of Northeast Quarter, 604 feet westerly of northeast corner, thence south 278 feet, thence west 150, thence north 278 feet more or less to the north line, othence east 150 feet to point of beginning, St. Louis County, State of Minnesota.

Section 3 Filing The city clerk (recorder) is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

Section 4 Iffective Date This ordinance takes effect upon its passage and publication ATE OF NINNESOT tion and the filing of the certified copies as directed in Section 3.
