ORDINANCE NO. 2.06

AN ORDINANCE ANNEXING CERTAIN UNPLATTED LANDS
AND EXTENDING THE CORPORATE LIMITS OF THE CITY OF ATWATER

The City Council of the City of Atwater does ordain as follows:

SECTION 1. Origination and Procedure. The owner of certain unincorporated and unplatted land contiguous to the City of Atwater petitioned for annexation pursuant to Section 414.033, Subd. 5, of Minnesota Statutes, which permits a property owner of unplatted land not exceeding 200 acres to petition the governing body of a municipality to have said land included within said municipality. Such petition was filed with the City Council of Atwater on the 13th day of August, 1975, and thereafter copies of said petition were filed with the Minnesota Municipal Commission, the Genessee Town Board and Kandiyohi County Board of Commissioners. That the area proposed to be annexed, plus other small contiguous parcels, the owners of which did not join in the petition for annexation, approximates 22 acres, and since all property owners of the lands to be annexed did not join in the petition, a public hearing thereon was called pursuant to published and mailed notice before the City Council on October 8, 1975, and adjourned to October 22, 1975, at which time it was determined there were no written objections to the annexation from any source, that the same would be in the best interests of the City and the territory to be annexed, and thereafter a resolution of the City Council was passed to accept the annexed land as a part of the municipality of Atwater and to adjust the corporate boundary accordingly. This annexation proceeding shall be deemed final upon the filing of a copy of this Ordinance with the Minnesota Municipal Commission, the Kandiyohi County Auditor, the Secretary of State for the State of Minnesota, and the Genessee Town Board Clerk.

SECTION 2. Description. Lands subject to this annexation are in the Township of Genessee, County of Kandiyohi, State of Minnesota, described as follows, to-wit:

All that part of the North Half of the Northwest Quarter (N $\frac{1}{2}$ of NW $\frac{1}{4}$) of Section Twelve (12), Township One Hundred Nineteen (119), Range Thirty-three (33), lying North of the Burlington Northern Railroad centerline, except the West 660 feet thereof.

SECTION 3. Annexation. The City Council hereby determines (1) that the annexation will be in the best interests of the City and the territory affected; (2) that the territory described herein abuts upon the City limits and is about to become urban or suburban in character; and (3) that none of said territory is included within the limits of any city or borough. Therefore, the area proposed for

annexation is hereby annexed to, and included within the City limits as effectually as if it had originally been a part hereof.

SECTION 4. Effective Date. This ordinance is deemed to be in full force and effect from and after its date of publication.
