## ORDINANCE #58

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF LESTER PRAIRIE TO INCLUDE CERTAIN UNIN-CORPORATED TERRITORY PRESENTLY OWNED BY THE VILLAGE OF LESTER PRAIRIE

UHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, Village or Borough; and,

UHEREAS, the below described territory is presently owned by the Village, abuts upon the municipal boundaries of ester Prairie and said territory is deemed to be urban in character; The Village Council of the Village of Lester

Prairie ordains:

Section 1. Territory to be annexed. The

corporate limits of the Village of Lester Prairie, Minnesota, are hereby extended to include the platted and unplatted territory described as follows, which territory is now owned by the Village and abutted upon territory already included within the Village limits and said territory is deemed to be urban in character:

> That property situated in Lot45 of Auditor's plat of Section 2 Township 116 North of Range 27 West, McLeod County, Minnesota, described as follows, to-wit:

The Northerly thirty (30) feet of the North Half (N 1/2) of Lot Forty-five (45) of Auditor's Plat of Section 2, Township 116 North of Range 27 West except the Northerly 117.98 feet of the Easterly 277.95 feet of said Lot 45 situated in said County and State for street purposes.

The Westerly One Hundred Fifty (150) feet of Lot Forty-five (45) of Auditor's plat of Section 2, Township 116 North of Range 27 West situated in said County and State for park purposes.

<u>Section 2.</u> <u>Filing</u>. The Village Clerk is Directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission, and the Clerk of Bergen Township.

Section 3. Effective Date of Annexation.

This Ordinance takes effect upon passage and

publication and the filing of certified copies as directed in Section 2.
