#### ORDINANCE NO. 1.7013

### AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MADELIA TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ABUTTING UPON THE CITY LIMITS

HMEREAS a cortain petition dated August 19, 1976, requesting annexation of the territory hereinafter described was duly presented to the Council on the 24th day of August, 1976;

AND WHEREAS the quantity of land embraced within the area described in the potition and bounded as described in 31.6 acres of platted and unplatted land, no part of which is included within the limits of an incorporated city or berough;

AND UNEREAS the potition was signed by all owners of said lands

AND WHEREAS a copy of said ennemation petition was duly served on August 24, 1976, upon the County Auditor of Watonwan County, Minnesota, and the Clerk of Madelia Townsolip Board, Medelia, Minnesota.

AND WHEREAS no objection to the annexation have been received from the Madelia Termohip Board, the Waterwan County Commissioners or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; nor had any objection been received from the Minnesota Municipal Board.

AND WHEREAS cald land is urban in character or about to become so.

AND WHEREAS the land described in the petition abuts upon the city at the east boundary thereof.

NOW, THEREFORE, the Council of the City of Medelia, Minnesoka hareby ordinas as follows:

#### Section 1.

- A. The City Council hereby determines that the annexation will be to the best interests of the City and to the territory effected.
- B. The territory described herein abuts upon the city limits and is urban or suburban in character or is about to become so.
- C. That mone of said territory is now included within the limits of any city, village or borough.

## Section 2.

The corporate limits of the City are hereby entended to include the platted and unplatted find described as follows and the same is hereby annexed to include the same within the city as effectively as if it had originally been a part thereof:

All of the East Half of the Northwest Quarter lying west of the M.T.H. No. 60 right-of-way, Section 26, Township 107 North, Range 30 West; also all of Lot B of Drigger's Subdivision of the West One-Half of the Northwest Quarter of Section 26, Township 107 North, Range 30 West, except the southerly 59.33 feet

thereoff also all of vacated First St. S. E. lying east of Plander's Avenue S. E., one opt the westerly 146.5 fact and the mortherly 33 feet thereoff also all of Flander's Avenue S. E. beginning at a point on the north boundary of "Riverside Cometery" approximately 59.33 feet morth of the coutherly boundary of Drigger's Subdivision and adjacent to Lot B of Drigger's Subdivision lying outside the present city limits; also beginning at the intersection of Eager Ave. N. E. and East Main Street in the City of Madelia, Watenwan County, Minnesotal themse mortherly on the center line of Eager Ave. N. E. to a point of intersection with the mortherly right-of-way of Second St. N. E.; thence contenty clong the easterly extension of the northerly right-of-way of M. T. H. No. 60; thence southwesterly along the westerly right-of-way of M.T.H. No. 60; thence southwesterly along the westerly right-of-way of M.T.H.

Scetion 3.

The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Waterwan County Auditor, and the Clerk of the Madelia Termship Board.

Soction 4.

This ordinance takes effect upon its passage and publication and filing of certified copies as directed in Section 3.
