## ORDINANCE NO. 83

AN ORDINANCE EXPENDING THE CORPORATE LIMITS OF THE CITY OF FRAZEE, MINNESONA TO INCLUDE CERTAIN LANDS

THE COUNCIL OF THE CITY OF FRAMES, MINISTERY, ROBE ORDATE:

City of Frazee, linnesota, by the owners of the following body of the real estate, to have such land included within the wity of Frazee, Fraze

dection 3. Therefore, the Council of the Cit of Frezee de nesota, hereby ordains and teclares that the property ereinbefore i scribed be and the same hereby is annexed to and included in the City of Fragee, Minnesota, as effectually as if it had originally been a part thereof.

Section 4. This ordinance shall be final and shall take affect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Aditor, the ecretary of State, and phe Clerk of the Town Board, and from and after its passage and publication.
