AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF GLENCOE TO INCLUDE CERTAIN
UNINCORPORATED TERRITORY
SURROUNDED BY LAND WITHIN THE CITY LIMITS
AND ABUTTING THEREON

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough, and

WHEREAS, this territory is surrounded by an area already included within the corporate limits of the city and is deemed to be urban in character.

The City Council of the City of Glencoe ordains:

Section 1. Territory Annexed. The corporate limits of the City of Glencoe, Minnesota, are hereby extended to include the territory described as follows, which territory now is and has heretofore been

surrounded by territory already included within the city limits:

Commencing at the South Quarter corner of Section Thirteen (13), Township One Hundred Fifteen (115) North of Range Twenty-eight (28) West; thence East along the South line of said Section 13 for 33.0 feet; thence North parallel with the North-South Quarter line of said Section 13 for 133.0 feet to the point of beginning; thence continuing North parallel with the North-South Quarter line of said section 13 for 100.0 feet; thence East 150.0 feet parallel with the said South line of Section 13; thence South parallel with the North-South Quarter line of said Section 13 for 100.0 feet; thence West parallel with the said South line of said Section 13 for 150.0 feet to the point of beginning, being a part of Lot 18 of Auditor's Plat of South Half of Section 13 and North Half of Section 24, Township 115 North of Range 28 West.

Section 2. Filing. The City Clerk is directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor of the county in which the property is located and the Minnesota Municipal Board.

Section 3. Effective Date of Annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.


