ORDINANCE NO. 18

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ELYSIAN TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated July 12, 1976, requesting annexation of the territory hereinafter described was duly presented to the Council on the 12th day of July, 1976; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is .96 acres of platted land, no part of which is included within the limits of an incorporated city or borough; and

WHEREAS, the petition was signed by all owners; and

WHEREAS, the Town Board of Janesville Township, Waseca County, filed a Consent to the Annexation and waived the 60 day requirement before a City Ordinance can be adopted on the annexation; and

WHEREAS, a hearing was duly held by the governing body of the City of Elysian, Minnesota on the proposed annexation after mailed notice; and

WHEREAS, the land described in the petition abuts upon the city limits at the south boundary thereof;

The Council of the City of Elysian, Minnesota, ordains:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is suburban in character; and (3) that none of said territory is now included within the limits of any city, or borough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:


Beginning at the North Quarter corner of Section No. 2, T. 108 N., R. 24 W., Waseca County, Minnesota,

thence West on the North line of said Section No. 2 a distance of 150.00 feet, thence South 198.00 feet, thence East 150.00 feet, thence North 198.00 feet to place of beginning.

Section 3. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Town Clerk, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.

Adopted by the Council this 9th day of August, 1976.

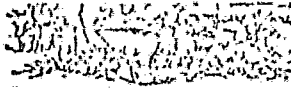
