AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF NEW RICHLAND TO INCLUDE CERTAIN
UNPLATTED LAND

A-2913

Introduced by Stanley Peterson

WHEREAS, a Petition has been filed with the governing body of the City of New Richland, Minnesota, signed by the owner of the following described real estate to have such land included within the City of New Richland, Minnesota:

The West Half (1/2) of Block Seven and all of Block 12, Ziegers Subdivision, as the same is platted and recorded in the Office of the Register of Deeds, Waseca County, Waseca, Minnesota.

The quantity of land embraced within the foregoing description and bounded as described is less than 2 acres.

THE CITY OF NEW RICHLAND DOES ORDAIN:

Section 1. That the annexation will be to the best interests of the City of New Richland and to the territory affected; that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City Government.

Section 2. That the property hereinbefore described be and the same is hereby annexed to and included in the City of New Richland as effectually as if it had originally been a part thereof.

Section 3. That this Ordinance shall be final and shall take effect and be in force from and after filing certified copies thereof with the Minnesota Municipal Commission, the Clerk of New Richland Township, the County Auditor and the Secretary of State and from and after its passage and publication.
