ORDINANCE NO. 181

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WACONIA TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated September 15, 1976, requesting annexation of the territory hereinafter described wasduly presented to the City Council of the City of Waconia on the 5th. day of October, 1976; and WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 2.57 acres of platted land, no part of which is included within the limits of an incorporated city, or borough; and WHEREAS, the petition was signed by all owners; and WHEREAS, the Township of Waconia has consented to the annexation of said land to the City of Waconia and has waived the sixty (60) day notice requirement provided by Statutes; and WHEREAS, the land described in the petition abuts upon the City limits at the South boundary thereof; and WHEREAS, Minnesota Statutes, Section 414.033, Subd. 5, provides that such lands may be annexed by Ordinance;

Section 1. <u>Declaration</u>: The City Council hereby determines (1) that the annexation will be to the best interests of the City of Waconia and of the territory affected; (2) that the territory described herein abuts upon the City limits and is about to become urban or suburban in character; and (3) that

THE COUNCIL OF THE CITY OF WACONIA, MINNESOTA, ORDAINS:

none of said territory is now included within the limits of any city, or borough.

Section 2. Territory Annexed. The corporate limits of the City of Waconia are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the City of Waconia as effectually as if it had originally been a part thereof:

> Lot 18, except the easterly 210 feet thereof, Volkenant's Second Addition to Waconia, according to the recorded plat thereof;

The Westerly 450 feet of Lots 19 and 20, said plat

The Westerly 50 feet of Lots 21, 22, 23, 24, 25 and the Westerly 50 feet of the Northerly 20 feet of Lot 26, said plat.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Municipal Commission of the State of Minnesota, the Secretary of State, the Township Clerk, the Auditor of Carver County.

Section 4. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
