ORDIHANCE NO. 454

AN ORDINANCE ANNEXING CERTAIN TERRITORIES TO THE CITY OF WASECA, MINNESOTA, AND EXTENDING THE CORPORATE LIMITES OF THE CITY OF WASECA TO INCLUDE CERTAIN UNINCORPORATED TRACTS OF LAND ABUTTING UPON THE CITY OF WASECA, AND ESTABLISHING THE ZONING THEREOF.

WHEREAS, the land hereinafter described is unplatted land of less than 200 acres situated in Woodville Township, Waseca County, Minnesota, and abuts upon the corporate boundary of the City of Waseca; and,

WHEREAS, certain petitions dated the 7th day of August, 1976, and <u>Fifth Day of Oct.</u>, 1976, have requested the City of Waseca to annox said lands to the City of Waseca and to extend the City boundaries to include the same; and,

WHEREAS, the quantity of land embraced within the area described in the petitions and bounded as described does not exceed 200 acres in area and consists of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and,

WHEREAS, the land described in the petition abuts upon the City of Waseca limits; and,

WHEREAS, Notice of Intent to Annex the hereinafter described land has been served upon the Town Board of Woodville Township and upon the County of Waseca; and

WHEREAS, said Township Board has signed Waivers of Hearing with regard to these proposed annexations; and,

WHEREAS, the City Council of the City of Waseca has determined that the annexation of said land to the City of Waseca will be to the best interests of the City of Waseca, and of the territory to be annexed;

NOW, THEREFORE, THE CITY OF WASECA DOES ORDAIN:

SECTION I

That there is hereby annexed to and included within the City of Waseca, Minnesota, the following described land in the County 1. LeRoy R. Hildebrandt and Donna A. Hildebrandt

Starting at the South quarter corner of Section 17, Township 107 North, Range 22 West; thence North 1979.81 feet on the North-South centerline of said section; thence East 33.0 feet at a deflection angle of 89°24' right to a point on the East right-of-way line of Eighth Street S.E., which point is hereinafter called the point of beginning; thence East 150.0 feet on an easterly extension of the last described line; thence South 106.0 feet at a deflection angle of 90°36' right; thence West 150.0 feet at a deflection angle of 89°24' right, to the East right-of-way line of said street; thence Worth 106.0 feet on said right-of-way line to the point of beginning; being part of the NW¼ SE¼ Section 17, Township 107 North, Range 22 West, and containing 0.37 acres; and

2. Lucille F. Schaumkessel

Starting at the South quarter corner of Section 17, Township 107 North, Range 22 West; thence North 1873.81 feet on the North-South centerline of said section; thence East 33.0 feet at a deflection angle of 89⁰24' right to a point on the East right-of-way line of Eighth Street S.E., which point is hereinafter called the point of beginning; thence East 182.0 feet on an easterly extension of the last described line; thence South 80.0 feet at a deflection angle of 90⁰36' right; thence West 182.0 feet at a deflection angle of 89⁰24' right, to the East right-of-way line of said street; thence North 80.0 feet on said right-of-way line to the point of beginning; being part of the NW¼ SE¼, Section 17, Township 107 North, Range 22 West, and containing 0.33 acres; and

3. Milton A. Clemons and Winifred C. Clemons

All that part of the SW¹/₄ of the SW¹/₄ of Section 5, Township 107 North, Range 22 West, Waseca County, Minnesota, described by: Commencing at the Southwest corner of said Section 5; thence North 0° East, assumbed bearing, 353 feet along the West line of said SW¹/₄ of SW¹/₄ to the centerline of 19th Avenue N.E.; thence North 90° East 451 feet along the centerline of said avenue to the True Point of Beginning; thence North 0° East 183 feet; thence North 90° East 84 feet; thence South 0° East 183 feet to the centerline of said avenue; thence North 90° West 84 feet along the centerline of said avenue to said True Point of Beginning; subject to a public street easement over the South 33 feet thereof; containing 0.35 acres, more or less; said area includes said street easement, subject to other restrictions and easements of record, if any; and

4. City of Waseca

A strip of land 66 feet in width, 33 feet on either side of a line described as follows: Beginning at the Northeast corner of the Northwest one-quarter of Section 20, Township 107 North, Range 22 West; thence Southwesterly along a 45 degree 51 minute curve to the right a distance of 77.43 feet along the curve; said tangent of above curve is an extension of the centerline of 8th Street Southeast and has a bearing of South 0 degrees 36 minutes West; thence continuing South 36 degrees 06 minutes West for a distance of 108 feet; thence along a 7 degree 58 minute curve to the right a distance of 119.72 feet along the curve; thence continuing South 45 degrees 37 minutes West a distance of 45.67 feet to the Easterly Right-of-Way line of State Highway No. 13 containing 0.53 acres more or less.

SECTION II

That all of the land described in Section I hereof shall be zoned residential within the meaning of the Zoning Ordinance of the City of Waseca, Minnesota.

SECTION III

That a copy of this Ordinance shall be filed with the Minnesota Municipal Commission, the Secretary of State of the State of Minnesota, the Waseca County Auditor, the Waseca County Register of Deeds, and the Clerk of the Woodville Township Board.

SECTION IV

That this Ordinance shall be effective upon passage and publication and the filing of certified copies as directed in Section III.
