## ORDINANCE NO. 489

A GENERAL-

AN ORDINANCE ANNEXING TO THE CITY OF KASSON, MINNESOTA, CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA, ALL BEING IN SECTION 33, TOWNSHIP 107 NORTH, RANGE 16 WEST, DODGE COUNTY, MINNESOTA

## THE CITY COUNCIL OF THE CITY OF KASSON DO ORDAIN:

Section 1. A petition has been filed with the City Council of the City of Kasson, signed by all of the owners of the land described herein, requesting the City Council to annex said land to the City of Kasson. The land described in said petition for annexation is located in Mantorville Township, Dodge County, Minnesota, described as follows:

That part of the East One-half of the Northeast Quarter of Section 33, Township 107 North, Range 16 West of the Fifth Principal Meridian bounded on the north by the north line of Third Street Northeast, in the City of Kasson, Minnesota, extended east, on the east by the east line of said Northeast Quarter, on the south by the northerly right-of-way line of the Chicago and Northwestern Railway Company and on the west by the west line of the said East One-half of the Northeast Quarter of said Section 33; excepting therefrom that part of the following described tract which lies within the above described tract: Commencing at the southeast corner of said Northeast Quarter; thence north, along the east line of said Northeast Quarter, a distance of 1,012.20 fet t thence deflect left 89°21'00" a distance of 10.2 feet to the point of beginning; thence continue on said line a distance of 695.20 feet, thence deflect right 88°32'00" a distance of 320.35 feet, thence deflect right 90°53'00" a distance of 708.70 feet; thence deflect right 91 30'00" a distance of 327.45 feet to the point of beginning; and also excepting that part of Third Street Northeast already platted as a part of Sunrise Second Addition to the City of Kasson, Minnesota. Containing approximately 20 acres.

Said petition has also been filed with the Town Board of Mantorville Township, with the County Board of the County of Dodge, and with the Minnesota Municipal Commission and more than sixty (60) days have elapsed since said petition was filed with the Town Board and no objections to annexation of the above described land have been filed by said Town Board with the Minnesota Municipal Commission. Section 2. The quantity of unplatted land included in said petition is approximately 20 acres.

Section 3. The City Council of the City of Kasson does hereby determine that the land described in Section 33 abuts upon the present territorial limits of the City of Kasson, is so conditioned as to be properly subjected to municipal government, and the annexation of said land will be in the best interest of the City of Kasson and the land affected.

Section 4. Therefore, the land described in Section 33 above is hereby annexed, added to and made a part of the City of Kasson, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. Present and future owners of the area annexed by this ordinance are hereby notified that in addition to the usual assessments, it is the intention of the City Council to assess against said annexed property all or a portion of the cost of any water lines, trunk line sanitary sewer, service connections and street construction, heretofore or hereafter, undertaken to serve the area annexed.

Section 6. Pursuant to Section 8 of Ordinance No. 437, known as the Zoning Ordinance of the City of Kasson, Minnesota, the lands herein annexed to the City of Kasson shall be designated as residential.

• Section 7. This ordinance shall take effect and be in force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Commission, the Mantorville Town Clerk, the County Auditor and the Secretary of State.
