MORRIS CITY ORDINANCE NO. 382

AN ORDINANCE ANNEXING CERTAIN PROPERTY TO THE CITY

THE COUNCIL OF THE CITY OF MORRIS DOES HEREBY ORDAIN:

SECTION 1: That the following described real estate be and hereby is annexed to the corporate limits of the City of Morris.

A tract of land located in the Southeast Quarter (SE $\frac{1}{4}$), Section Two (2), Township One Hundred Twenty-four (124) North, Range Forty-two (42) West, described by metes and bounds as follows: Commencing on the South line of Lot 3 in Block 7 of Elles University Addition to the City of Morris, Minnesota, which point is 40 feet west of the southeast corner of said Lot 3, running thence due South a distance of 375.03 feet, thence due east a distance of 500 feet, thence due north a distance of 375.03 feet to a point on the south line of Lot 10 in Block 7 of Elles University Addition to the City of Morris, Minnesota, which point is 26 feet west of the southeast corner of said Lot 10, thence due west along the south line of Lots 10, 9, 8, 7, 6, 5, 4 and 3 of Block 7 of Elles University Addition to the point of beginning.
