I, Sandford A. Howard, first being duly sworn, depose and say:

Prior to August 2, 1923, this deponent was duly appointed by the Secretary of State of the State of Minnesota, pursuant to Chapter 417, Laws of 1921, as supervisor of census and Mr. Earl Keen, Mr. Roy Coyne, Mr. I. R. Sher, Mrs. Agnes Murphy, Miss Belle LaVaque, Miss Tunie Toivola, and Mrs. Mettie A. Beer all of School District No. 27, State of Minnesota, were duly appointed by said Secretary of State, pursuant to said act, as enumerators of the census, and this deponent and the seven above mentioned enumerators were directed by the Secretary of State aforesaid, to take a census of the residents of Independent School District No. 27, St. Louis County, Minnesota.

That thereafter, this deponent and said enumerators agreed in writing and under oath to perform their duties in connection with said census faithfully and impartially and under the direction of said secretary of state, as more fully appears from Exhibits A, B, C, D, E, F, G, and H., hereto attached and made a part hereof.

That, between the dates of August Second and October Sixth, 1923, all of the inhabitants of said school district were personally interviewed by one of the enumerators above mentioned, working under deponent's supervision; that a separate card was prepared for each of the residents of said district containing the name of such resident and also containing other data, required by the Secretary of State; that these cards were prepared by said enumerators under the direction of this deponent and said cards have been duly filed with said secretary of state; that the facts stated on said cards are true and reference is hereby made thereto for that purpose.

That, as a result of said census, it appears that there were on October 6, 1923, twenty-two thousand four hundred and fifty-three residents (22,453) of said school district.

That, after the enumeration of the inhabitants of said district, each of the seven above mentioned enumerators and this deponent executed an affidavit to the effect that the facts stated in said cards were true. Said affidavits were hereto attached and made a part hereof and


