SECTION I: That Sections 1, 2, 3, 4, 5, 6, 7 of Chapter IX of the Austin City Charter be hereby amended by striking out said Sections 1, 2, 3, 4, 5, 6, 7 in their entirety substituting in lieu thereof the following:

SECTION I. Powers of the Common Council to establish and maintain Fire Department.

The Common Council shall have the power to create, keep, and maintain a Fire Department; purchase or lease equipment; erect and maintain buildings and other structures, acquire land by purchase, lease, donation, or condemnation for that purpose; adopt ordinances, resolutions, and regulations for the prevention and control of fires and similar hazards; adopt by reference such regulation of any state agency, state or national code as may be deemed necessary; provide for the enforcement thereof; employ such personnel that may be needed and provide for the compensation and regulation of such personnel; contract to provide emergency fire fighting services to other municipalities, townships, or governmental subdivisions; and shall have the power to do any and all things necessary to operate a fire department within the City of Austin.

SECTION II: The amendment above set forth shall become effective ninety (90) days after publication of said Ordinance, unless within sixty (60) days after the publication of said Ordinance a petition for a referendum is filed with the City Recorder pursuant to said M.S.A. 410.12 subdivision 7.

That Amendment as above set forth became effective on December 9, 1976.
