AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WINTHROP TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

(Danrou Property)

WHEREAS, a certain petition dated April 5, 1976, requesting annexation of the territory hereinafter described was duly presented to the City Council on the 5th day of April, 1976; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately one acre of unplatted land, no part of which is included within the limits of an incorporated city; and

WHEREAS, the petition was signed by two owners, constituting all of the owners thereof; and

WHEREAS, the resolution of the Town Board of Transit Township has been received waiving all objections to the annexation of said land and waiving the 60 day notice period thereof; and

WHEREAS, the land described in the petition abuts upon the City limits at the Northeastly boundaries thereof;

NOW, THEREFORE, the City Council of the City of Winthrop, Minnesota, ordains:

Section 1. The City Council hereby determines (1) that the annexation will be in the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is or is about to become urban or suburban in character; and (3) that none of the said territory is now included within the limits of any city.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described hereafter and made a part hereof and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof. The land hereinabove mentioned is described as:

A parcel of land in the Southwest Quarter of the Southwest Quarter of Section 32, Township 113, Range 29, Sibley County, Minnesota, described as follows:

Commencing at a point 267.8 feet North of and 33 feet East of the Southwest Corner of Section 32, Township 113, Range 29; thence North a distance of 208.71 feet; thence East a distance of 208.71 feet; thence South a distance of 208.71 feet; thence West a distance of 208.71 feet to and terminating at the given point of beginning.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Town Clerk of Transit Township and the County Auditor.

Section 4. Effective Date. This ordinance shall take effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
