## Ordinance Number 94

AN OMDINANCE EXTENDING THE COMPORATE LIMITS OF THE CHTY OF VINTEROP TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEPTING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

(Omeou Rioporty)

VMEREAS, a cortain petition dated April 5, 1976, requesting annexation of the territory hereinafter described van duly presented to the City Council on the 5th day of April, 1976; and

WHENEAS, the quantity of land ombraced within the area described in the potition and bounded as described is approximately one acre of unplatted land, so part of which is included within the limits of an incorporated city; and

WHEREAS, the petition was signed by two owners, constituting all of the owners thereof; and

WHREAS, the resolution of the Town Board of Transit Township has been received valving all objections to the annexation of said land and valving the 60 day notice, period thereof; and

WHEREAS, the land described in the petition abute upon the City limits at the Northeasterly boundaries thereof;

NOV, THEREFORE, the City Council of the City of Winthrop, Elamesota, ordains:

Section 1. The City Council hereby determines (1) that the annexation VIII be in the best interests of the City and of the territory affected; (2) that the territory described herein abute upon the City limits and is or is about to become urban or suburban in character; and (3) that none of the said territory is now included within the limits of any city.

Section 3. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described hereafter and made a part hereof and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof. The land hereinabove mentioned is described as:

A parcel of land in the Southwest Quarter of the Southwest Quarter of Section 32, Township 113, Range 29, Sibley County, Minnesota, described as follows:

Commonding at a point 267.8 feet North of and 33 feet East of the Southwest Corner of Section 32, Township 112, Range 29; thence North a distance of 208.71 feet; thence East a distance of 208.71 feet; thence of 208.71 feet; thence of 208.71 feet; thence of 208.71 feet; thence vest a distance of 200.71 feet to and terminating at the given point of beginning.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Your Clerk of Transit Township and the County Auditor.

Section 4. Iffective Date. This ordinance shall take effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
