## ORDINANCE NO.

AN ORDINANCE DECLARING CERTAIN LAND CONTIGUOUS AND ABUTTING ON THE CORPORATE LIMITS OF THE CITY OF LENGBY, COUNTY OF POLK, STATE OF MINNESOTA, TO BE A PART OF SAID CITY.

WHEREAS, all the owners of the tract of land hereinafter described abutting upon the City of Lengby, Polk County, State of Minnesota, a muncipal corporation Culy incorporated under the laws of the State of Minnesota, and having less than 10,000 inhabitants, having petitioned the City Council of the City to have said tract of land annexed to the City, and to have said Council by Ordinance declare said tract of land annexed to the City to the end that such territory shall become a part of the City as effectually as if it had been originally a part thereof, all in accordance with Section 412.041 of the Minnesota Statutes.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LENGBY, COUNTY OF POLK, STATE OF MINNESOTA, DOES ORDAIN:

Section 1. The tract of land situated in the County of Polk and State of Minnesota abutting upon the City and described as follows, to-wit:

All that part of the Northwest Quarter of the Southwest Quarter (NW $\chi$ SW $\chi$ ) in Section Twenty-eight (28) of Township One Hundred Forty-seven (147) North of Range Thirty-nine (39) West of the Fifth Principal Meridian in Polk County, Minnesota, described as follows: Beginning at a point on the line between the North Half and the South Half of the Southwest Quarter in said Section 28, which is 30 feet West of the Southeast Corner of said NW $\chi$ SW $\chi$  in said Section 28, thence North and parallel to the line between the West Half and the East Half of said SW $\chi$  in Section 28 a distance of 214.5 feet to the place of commencement of the tract hereit intended to be described, thence continuing North and parallel to the line between the West Half and the East Half of said SW $\chi$  of Section 28 a distance of 500 feet, thence West and parallel with the line between the South Half and the North Half of said SW $\chi$  of Section 28 a distance of 528 feet, thence South and parallel to the line between the South Half and the East Half of said SW $\chi$  of Section 28 a distance of 660 feet, thence East and parallel to the line between the South Half and the East Half of said SW $\chi$  of Section 28 a distance of 528 feet, thence East and parallel to the line between the South Half and the East Half of said SW $\chi$  of Section 28 a distance of 528 feet, thence East and parallel to the line between the South Half and the North Half of said SW $\chi$  of Section 28 a distance of 528 feet to the place of commencement, containing 8 acres, more or less,

is hereby declared to be annexed to said City of Lengby, which territory hereby becomes a part of said City as effectually as if it had been originally a part thereof.

Section 2. That the City Clerk be and is hereby directed forthwith upon passage, publication and recording of the Ordinance, to cause a certified copy thereof to be recorded and filed in the Office of the Register of Deeds of said County of Polk, with the Clerk of the Township of Columbia, Polk County, Minnegota, with the Minnegota Municipal Commission and with the Secretary of State.

Section 3. That this Ordinance shall take effect and be in force from and after its passage, publication and recording.
