Prior to October 9th, 1923, this deponent was duly
appointed by the secretary of State of the State of Minnesota, pur-
suant to Chapter 417, Laws of 1921 as supervisor of census and
Earl Keen, Roy Coyne, Mrs. Agnes Murphy, Miss Tunie Toivola and Miss
Belle LaVague, all of the Village of Hibbing and the State of
Minnesota, were duly appointed by said secretary of State, pursuant
to said act, as enumerators of the census, and this deponent and the
five above mentioned enumerators were directed by the secretary of
state aforesaid to take a census of the residents of the Village of
