ORDINANCE NO. A-76-123

AN ORDINANCE TO AMEND AN ORDINANCE KNOWN AS CHAPTER 13, UNCODED ORDINANCES IN EFFECT, OF THE CITY CODE OF THE CITY OF MANKATO, MINNESOTA

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City of Mankato, does not exceed 200 acres, and is deemed to be or about to become urban in character;

THE CITY OF MANKATO, MINNESOTA, DOES ORDAIN:

- That the annexation will be to the best interest of the City and of the land affected;
- 2. That the land described herein abuts upon the City limits and is or is about to become urban in character; and
- 3. That none of said land is now included within the limits of any city, village, or borough;

NOW, THEREFORE, BE IT HEREBY RESOLVED, by the Council of the City of Mankato, that the corporate limits of the City are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been part thereof:

Beginning at the Southwest Corner of the Southeast Quarter of Section 17-T108N-R26W, thence North on the West line of the Southeast Quarter of said Section 17 to the Northwest Corner of the Southwest Quarter of the Southeast Quarter, thence East and parallel with the South line the Southeast Quarter of said Section 17 to the centerline of Pohl Road, thence in a Northerly direction on the centerline of Pohl Road to a point where the centerline of Pohl Road intersects with the centerline of Glenwood Ayenue, thence on the centerline of Glenwood Avenue to a point where the centerline of Glenwood Avenue intersects with the centerline of Agency Road, thence in a Southerly direction on the centerline of Agency Road to a point where the centerline of Agency Road intersects with the Westerly right-of-way line of Truck Highway No. 22, thence on the Westerly right-of-way line of Trunk Highway No. 22 to a point where the Westerly right-of-way line intersects with the South line of Section 17T-108N-R26W, thence on the South line of the Southeast Quarter West to the point of beginning.

Containing approximately 42 acres, more or less.

The City Clerk is hereby directed to file certified copies of the Ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

This Ordinance shall take effect thirty (30) days after the date of its passage and due publication and filing thereof.
