ORDINANCE NO. 268

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WINDOM, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED TERRITORY BORDERED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, Certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough; and

WHEREAS, 60% or more of the perimeter of this territory is bordered by lands already included within the corporate limits of the City of Windom and is deemed to be urban in character; and

WHEREAS, said territory is approximately 2.8 acres in area; and

WHEREAS, on October 2nd, 1975 the City caused notice of intent to annex said territory to be duly served upon the Town Board of Great Bend Township; and

WHEREAS, on October 7, 1975 the Town Board of Great Bend Township approved of said annexation and waived the 60-day waiting period in which to voice objections to said annexation.

BE IT ORDAINED BY THE CITY OF WINDOM, MINNESOTA AS FOLLOWS:

1. The City Council hereby determines that the annexation will be to the best interest of the City and to the territory affected and that none of the territory is now included within the corporate limits of any other city, village or borough.

2. The corporate limits of the City of Windom, Minnesota are hereby extended to include the unplatted territory in Great Bend Township, Cottonwood County, Minnesota as follows; 60% or more of the perimeter of which territory is bordered by territory already included within the city limits:

All that part of the South Half of the Southwest Quarter of Section 24, Township 105, Range 36 bounded by the following described lines:

- (1) On the Southwesterly side by Trunk Highway No. 71,
- (2) On the Northwesterly side by a line drawn parallel with and distant 295 feet Northwesterly, measured at right angles, from the Northwesterly right-of-way line of Trunk Highway No. 60,
- (3) On the Northeasterly side by the Southwesterly line of tract annexed to the City of Windom by City Ordinance No. 258, adopted June 5, 1973,
- (4) On the Southeasterly side by Trunk Highway No. 60; containing 2.8 acres, more or less.
